Proceedings of EHT/HT consumers interaction meeting held on 21-10-2021 under the Chairmanship of the SEE(O) O&M Zone Kalaburagi.

At the outset SEE O&M Circle GESCOM, Bidar welcomed I/c CEE O&M Zone GESCOM Kalaburagi, CA O&M Zone GESCOM Kalaburagi, and all the officers present in the meeting along with the EHT/HT consumers.

The I/c CEE O&M Zone Kalaburagi enquired about the various problems faced by EHT/HT consumer and guided the concerned officers as well as consumers accordingly in detail.

1) KHT-06: M/s Karanja (Rubbers) Industries Pvt Ltd:-

The representative of M/s. Karanja (Rubbers) Industries Pvt Ltd, complained regarding power supply interruption to the industry, AEE Kamthana explained that last month there was relay setting problem in Kolar 110kV MUSS,.I/c CEE O&M Zone Kalaburagi directed AEE Kamthana to reduce the interruptions by taking line maintenance work and also directed to take up the new line works...

2) KHT-05: M/s Karanja (Paper Mill) Industries Pvt Ltd:-

The representative of M/s. Karanja (Paper Mill) Industries Pvt Ltd, requested to refund the excess amount of 5.06 Lakhs, as he has written letter regarding the same and asked for the clarification. AO Humnabad explained that, it will be cleared after getting clarification from the AO I/A Humnabad.

3) P22715:- M/s Priyanka Fullars Earth Industries :-

The representative of the company has asked for the clarification for his industry, during the registration he requested for 50HP of LT power supply and serviced with the same, after that he requested and registered for the 150HP of power supply as HT, therefore the concerned officers also processed for HT and ready to service as HT installation. But now the consumer is not in need of HT power and requesting to refund the deposit or to adjust the registration / deposit /processing fee to his other new industry "DGP food industry" which he is going to start shortly. I/c CEE O&M Zone Kalaburagi convinced the consumer that, the processing fee will not be refunded and deposit will be adjusted if possible and advised the concern to operate all the three files parallely.

The consumer expressed that, during the period of Covid-19, the exemption is not being effected in their bills.

SEE Bidar assured the consumer that, he will look into the matter and resolve the above problem within 30 days.

4) ADHT-08:-M/s Akakasha Infrastructure Kamalnagar:-

The said installation is a stone crusher having Contract Demand of 316kVA, during October-21, billing there was mistake wherein, instead of considering 269kVA i.e 85% of 316kVA, 85% of 269kVA is billed.

SEE Bidar assured the consumer that, he will look into the matter and resolve the problem.

5) HT-61:- M/s Shree Metals Bidar:-

The representative of the company expressed pleasure for un-interrupted power supply to his company.

Later, the SO Andoor has expressed the problem of line crossings infront of 110kV MUSS wherein, around 15 feeders emanates from 110kV MUSS Kolar, to clear any line fault in a single feeder, minimum of 3-4 feeders of line clear needs to be availed due to this crossings. Frurther, it may be resolved/reduced by making 1.5km of link line, the EE Bidar requested AEE Nodal officer Chidri KPTCL to provide the cable and AEE KPTCL Chidri assured that, the cable will be provided to avoid the line crossings and interruptions of the feeders at 110kV MUSS Kolhar. I/c CEE Zone Kalaburagi directed to EE Bidar to look into the matter and take necessary action.

Finally, meeting concluded with vote of thanks by the chair.
