Mylar sugar limited was granted a power supply of temporary power supply RR NO HTBRB23936 which is disconnected on dated 30.11.2019 as requested by consumer to disconnect on dated 25.12.2016 due to the misplacement of the meter temporary installation deposit refund was delayed and deposit refund made on dated 30.11.2019 as consumer requested to adjusted the deposit of temporary installation to the revenue arrears of installation holding RR .NO HTBRB24793 due todelay in adjusting the deposit to Arrears of their another installation interest on Arrears was raised to Rs. 171000/- from February 2016 to December 2019. Hence consumer is requesting to waive off the interest on Arrears RR NO:HTBRB24793.

In response to this Chief Engineer (Ele) O & M zone Ballari, & Superintending Engineer (Ele), O & M Circle Gescom Ballari stated this matter is already in discussion in consumer grievance redressal forum and assured the consumer to take early steps regarding this issue and solve the issue as early as possible.
