

In the matter of: Fixing of uniform remuneration to non-official members of the Consumer Grievance Redressal Forums (CGRFs) established in the jurisdiction of Distribution Licensees

Preamble:

The Commission has been frequently receiving the requests from the non-official Members of CGRFs, nominated by the Commission, for fixing of uniform honorarium in the State, stating that there is difference in the remuneration being paid to them by the Distribution Licensees. Considering their request, the Commission has decided to approve uniform remuneration for non-official members of the CGRFs. Hence, the following order:

ORDER

The Commission hereby approves monthly honorarium of Rs. 3000/-, sitting fee of Rs. 1000/- per sitting, to non-official Members of the CGRFs, with effect from 1st April 2022. They are also eligible for TA&DA as admissible to a Class I Government servant.
