It is noticed that the urban feeder was extended to the outside town limits and causing more interruption by availing hand trip and LC and this was avoided by providing GOS but after GOS installation also consumer facing the same issue.

Superintendent Engineer (Ele) O & M circle, Gescom Ballari, instructed to Executive Engineer O & M Division, Gescom HB Halli to Verify the spot as there may be internal issue as the other consumer or not facing any such issue specially for this installation may be any internal Power issues might be causing the frequent interruption in the power supply.
