At the outset, the Superintending Engineer (Elect), O&M Circle, GESCOM, Kalaburagi welcomed all the officers and EHT/HT consumers of Yadgir district. The consumer wise discussions and suggestions received are as mentioned below:

- (1) M/s Badal Industries Yadgir, Sri Layak Hussain Badal, Mob: 9886040250, the consumer expressed that, the 11KV F-4 industrial feeder clubbed & extended upto Halgera village, due to which
  - (A) Industrial feeder is tripping 2 to 3 times in an hour
  - (B) Facing the low voltage problems, requested for creation of new 11KV feeder only for industrial area Yadgir.

The Executive Engineer (Ele), O&M division, Yadgir stated that, the 11KV F-4 industrial feeder is feeding from 110KV MUSS Yadgir to Halgera village i.e approximately 11Kms. Hence, the tail end consumers are facing low voltage problems. Hence, the new 11KV industrial feeder is proposed from 220KV sub station Ramasamudra (work is in progress).

(2) Sri Faizan Muddin M/s Noor Rice Industries Yadgir consumer complained about the problems being faced on the production due to frequent tripping of feeder and power failure, requested to minimize the interruptions.

The Asst. Executive Engineer (Ele), O&M sub division, Yadgir stated that, the issue is resolved.

(3) Sri Vijay Kumar, Shree Lakshmi Paraboiled Rice Mill Yadgir has requested to sanction the new post of AEE HT Rating to Yadgir division for early attending of HT installations related works.

The Superintending Engineer (Elect), O&M circle, stated that, the matter will be discussed with the Chief Engineer Electy., O&M Zone, GESCOM, Kalaburagi.

(4) M/s Arshad Badal Rice Industries Consumer complained about the problems being faced on the production due to frequent tripping of feeder and power failure and requested to minimize the forseen interruptions on 11KV F-10 Ambedkar Nagar feeder.

The Superintending Engineer (Elect), O&M Circle, directed the Asst. Executive Engineer Ele, O&M sub division, Yadgir to take necessary action to minimize the interruptions by jungle clearance and avoid un-necessary handtrips.

- (5) M/s A.K Agro Industries consumer requested to
  - (A) Provide the GOS &
  - (B) Straighten the slanted poles at near A.K Agro Industries Yadgir.

The Superintending Engineer (Elect), O&M Circle, directed the Asst. Executive Engineer Ele, O&M sub division, Yadgir to carry out the maintenance works by jungle clearance, tightening of loosed spans, replacement of charred/chipped insulators & to make arrangements for providing 01 No. of GOS at said place at the earliest.

(6) HT consumers are requested for making necessary arrangements for making of payments through RTGS to overcome Check Dishonoured problems.

The Superintending Engineer (Elect), O&M Circle, directed the Accounts Officer, Yadgir to discuss with Chief Financial Officer, GESCOM, Kalaburagi and problem should be resolved.

The meeting concluded at 2:00 PM duly thanking GESCOM officers along with the EHT/HT consumers.
