Consumer Details	Consumer Grievance	Remarks
Garudadhri Developers, Malapura.	Low voltage since last 3 months.	The installation is 17KMs away from the 110KV Thoranagal MUSS and once in a while voltage issues are observed specially during IP Set Peak seasons. However 110KV Anthapura sub station proposed was approved and work to be taken up by KPTCL. Meanwhile all necessary actions from concerned Sub Division AEE and SO will be taken to resolve the issues.
DRDO, Kodal Village.	Frequent power supply interruption	As the existing 33KV line is tapped from 33KV Thoranagal - Vittlapura line, informed the official to construct exclusive 33KV or 110KV line from 110KV KIADB sub station under self execution based on load requirement. Due to monsoon there were interruptions in 33KV Thoranagal - Vittlapura line, there are no interruptions since last month.
Sudhakar polymers Pvt. Ltd.,	Shifting of HT line due to frequent power supply interruption	Estimates prepared for the shifting of 11KV line and the work will be taken up shortly.
