NOTIFICATION

In exercise of the powers conferred by Sub-Regulation (2) and (3) of regulation 30 and 43 of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010 read with section 21 of the General clauses Act, 1897 (Central Act 10 of 1897) and in supersession of the earlier notifications or orders issued in this behalf, the Government of Karnataka, hereby directs 650 Volts as "Notified Voltage" to carry out the Periodical Inspection and Testing of Installations before commencement of supply or recommencement after shutdown for six months and above respectively except the installations covered under the Karnataka Lifts, Escalators and Passenger Conveyor Act, 2012 (Karnataka Act 9 to 2013) and rules made thereunder and also the Karnataka Cinemas (Regulation) Act, 1964 (Karnataka Act 23 of 1964) and rules made thereunder.

Provided that, the installations belonging to Government of India or its undertaking are excluded from inspection by the Electrical Inspector of the State.
