
NOTIFICATION

In exercise of the powers conferred by Sub-Regulation (1) of Regulation 36 of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations 2010 read with section 21 of the General Clauses Act, 1897 (Central Act 10 of 1897) and in supersession of the earlier notifications or orders issued in this behalf, the Government of Karnataka, hereby notifies; that all multi-storeyed buildings in the State of Karnataka of more than fifteen metres in height (as defined in National Building Code) with connected load of exceeding 250W and 100Volts shall be inspected by the Electrical Inspector or any officer appointed to assist the Electrical Inspector.

Provided that, the installations belonging to Government of India or its undertaking are excluded from inspection by the Electrical Inspector of the State.
