For the implementation of action points suggested by the Government of India and Energy Department of GoK, the following instruction are to be followed for collecting the number of mandatory documents required for obtaining the electricity connection in line with KERC regulations for arranging power supply to the HT/LT industrial consumers.

a. Proof of Identity of the user. (Adhar card, EPIC, Driving license, Passport. Pan card etc.,)

b. Proof of ownership of the premises or proof of occupancy with consent of owner, in the absence of such consent, indemnity bond as per Annex-8 of KERC regulations.

c. Authorization documents in case of firm or Company (Partnership deed in the case of a partnership firm, or Memorandum of Association & Articles of Association and Certificate of incorporation, in the case of a limited company/Limited liability Partnership firm).
