
## CHAPTER - 1

### INTRODUCTION

### 1.0 Gulbarga Electricity Supply Company Ltd.:

The Gulbarga Electricity Supply Company Ltd., (GESCOM) is a Distribution Licensee under the provisions of Section 14 of the Electricity Act, 2003 (hereinafter referred to as the Act). The GESCOM is responsible for purchase of power, distribution and retail supply of electricity to its consumers and also providing infrastructure for Open Access, Wheeling and Banking in its area of operation in the six Districts of the State as indicated below:



The GESCOM is a company registered under the Companies Act, 1956, incorporated on 30<sup>th</sup> April, 2002 and commenced its operations on 1<sup>st</sup> June, 2002.
