Preamble:

- I. For Rural Electrification works of Gulbarga district in Karnataka under 12th Plan Rajiv Gandhi Grameen Vidyutikaran Yojane (RGGVY) on Total Turnkey basis in GESCOM, Gulbarga of the State of Karnataka, LOI was issued to M/s. Shreeshwar Electricals Pvt. Ltd., Dharwad vide ref. 1 above the Detailed Work Award (DWA) issued vide ref. 2 above. The total awarded cost of the project is Rs.14.08 Crs.
- II. The scope of the work included as below:

Creation of Infrastructures:

- III. As per Clause 1.1 (ee) of GCC of the DWA, the completion period was 24 months from the date of LOI i.e., up to 16.3.2017.
- IV. However the contractor M/s. Shreeshwar Electricals Pvt. Ltd., Dharwad failed to commence the works as per the terms and conditions of the contract.
- V. So notice was served to the contractor vide ref. 3 above for the non-commencement of works and thereby causing delay in completion of the awarded works in spite of procuring materials towards electrification of BPL households worth Rs.4.25 Crs. for which GESCOM had made payments.
- VI. It was further noted that the contractor failed to take any action towards creation of infrastructure works. The firm did not respond to any correspondences by GESCOM and receive phone calls.
- VII. Further notices were issued vide ref. 4 &5 to the agency for non-commencement of work as per the terms and conditions of the award culminating in issuance of final notice vide ref. 6 above wherein the firm was declared as 'Defaulter' and to initiate action as per Clause 36 of GCC towards which the response of the firm was sought to be submitted on or before 15.12.2016.
- VIII. In order to sort out any issues pertaining by the contractor in the subject work, a joint meeting was convened on 15.12.2016 at Corporate office, GESCOM vide ref. 7 above which the agency failed to attend.
- IX. As a final opportunity the contractor was once again asked to attend the meeting convened on 24.12.2016 vide ref. 8 above.
- X. Ultimately a joint meeting of the contractor and GESCOM was held on 26.12.2016 chaired by the MD GESCOM wherein directions were issued to the contractor as follows:
 - i. To commence the work before 10th Jan 2017.
 - ii. To complete the entire electrification of BPL Households within 2months.
 - iii. To complete the entire scope including creation of infrastructure before 31st March 2017.
 - iv. If the work is not commenced within 10th Jan 2017, action shall be taken as deemed fit by GESCOM invoking terms & condition of DWA.
 - v. The contractor to furnish an undertaking to the above effect.

Further, MDGESCOM instructed that the Chief Engineer Electy., Gulbarga Zone, the Superintending Engineer (El), O&M Circle, Gulbarga and all the Executive Engineers (El), O&M Divisions of Gulbarga District who also attended the meeting shall regularly monitor the progress of the subject works and submit reports to Corporate Office and to extend all necessary assistance to the agency to keep up the above time lines and any adverse reports by the field officers, the Corporate Office shall initiate suitable action against the contractor. The proceeding of the joint meeting is referred as ref. 10 above. An undertaking to the above effect was also submitted by the contractor vide ref. 11 above wherein the contractor committed to complete the works awarded to him by 31st Mar 2017, otherwise GESCOM is free to take action as deemed fit.

- XI. But the contractor failed to keep up its commitment. In this regard the Superintending Engineer (El), O&M Circle addressed to the contractor for non-commencement of works vide ref. 12 above.
- XII. For failure in commencement of works by the contractor and so to initiate action as per terms and conditions of the contract notice was issued to the contractor vide ref. 13 above.
- XIII. Considering the non-commencement of works, one more joint meeting was conducted on 14.6.2017 (ref. 14 above) chaired by MD GESCOM wherein month wise time lines were set to the contractor for completion of electrification of BPL households from 15th June-17 to 23rd Sept-17.
- XIV. However the contractor failed to adhere to the above targets and so further notice for non-compliance was issued vide ref. 15 above.
- XV. In consideration of the importance and urgency of the works under RGGVY to be completed within the timelines so as to claim the grants from MoP, further joint meeting was held with the agency on 18.7.2017 chaired by MD GESCOM wherein the poor progress was seriously reviewed and insisted upon the contractor to complete electrification of at least 2000 Nos. of BPL households per week.
- XVI. In spite giving notices for the frequent failure on the part of the contractor requiring him to remedy or to take steps to remedy the same, it is noted that no substantial progress has been made by the contractor and as on date only few Nos. BPL households have

been completed by him as against the awarded BPL households of 26518 Nos.

XVII. Under the circumstances explained above and reasons thereof, it was ordered to short close the works of Rural Electrification works of Gulbarga district in Karnataka under 12th Plan Rajiv Gandhi Grameen Vidyuthikaran Yojane (RGGVY) awarded to M/s.Shreeshwar Electricals Pvt. Ltd., Dharwad on Total Turnkey basis in GESCOM, Gulbargaand to impose Clause 36 of General Terms and Conditions of the DWA for persistently neglecting to carry out its obligations under contract and initiate further action as per Clause 36.2.2 of GCC of DWA

Under the circumstances explained above and consequent to short closing the works of Rural Electrification works of Gulbarga district in Karnataka under 12th Plan Rajiv Gandhi Grameen Vidyuthikaran Yojane (RGGVY) awarded on Total Turnkey basis in GESCOM, M/s. Shreeshwar Electricals Pvt. Ltd., Dharwad is Blacklisted for a period of two years from the date of short closing of the scheme.
