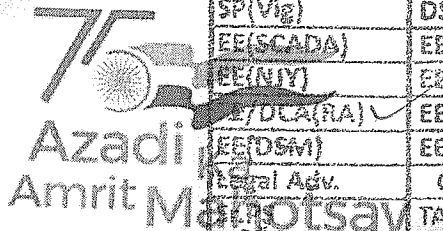

**Subject:- Selection for the post of Member (Law Background) in the Haryana Electricity Regulatory Commission – Invitation for applications – Regarding.**  
Sir,

The Haryana Electricity Regulatory Commission (HERC) was constituted in 1998 with a Chairman and two Members under the Haryana Electricity Reforms Act, 1997 to regulate the Electricity Industry in the State. One post of Member (Law Background), HERC has fallen vacant. A suitable person has to be selected for this post and a Selection Committee has been constituted for this purpose. The qualifications for appointment of Member of HERC and his terms of office and conditions of service are provided in Section 84 and 89 of the Electricity Act, 2003, respectively. As per section 84 of the Electricity Act-2003, the Chairperson and the Members of the State Commission shall be persons of ability, integrity and standing who have adequate knowledge of and have shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management.

2. As per directive of Hon'ble Supreme Court of India vide judgement dated 12.04.2018 in the Civil Appeal no. 14697 of 2015, one member of the State Commission should be a person, who is, or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge.

3. The selected member shall hold office for a term of five years from the date he enters upon his office provided that no member shall hold office as such after he has attained the age of sixty five years, as provided in Section 89 of the Act.

4. As per Rule 3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules 1998 as amended from time to time, the pay of the members shall be Rs. 2,05,400/- per month in the pay matrix level 16 (corresponding to the pay scale of Rs. 75,500/- 80,000/-) and shall get an annual increment as specified in the vertical cell's of applicable pay matrix level 16 as per the Government of India, Ministry of India, (Department of Expenditure) Notification No. 1- 2/2016-1C, dated the 25th July, 2016. Provided that the pay of the Chairman and members shall be subject to deduction of the gross amount of pension including any commuted portion thereof if already getting".

5. The last date of receipt of applications, both by post/e-mail, is 21 days from the date of issue of this letter i.e. 17.01.2023 by 05.00 PM. The address for correspondence is:-

6. I am directed to request you to give wide publicity and also to send the applications of the eligible and willing candidates, if any, with the following information:-

A) The bio-data of the proposed candidate should include the following details alongwith his/ her signature and date:

- i) Name
- ii) Age & Date of Birth
- iii) Position now held
- iv) Educational Qualification
- v) Details of posts previously held and experience in any of the field of engineering, finance, commerce, economics, law or management.

B) The communication should contain a letter from the person proposed intimating the details of any office, employment or consultancy agreement or arrangement which he/she has in his/her own name or in any firm, association or persons or body corporate, or in the names of any relative, carrying on any of the following business, namely:-

- i) Generation, transmission, distribution or supply of electricity.
- ii) Manufacture, sale or supply of any fuel for generation of electricity.
- iii) Manufacture, sale, lease, hire or otherwise, supply or dealing in machinery, plant, equivalent, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity and
- iv) Any entity providing professional services or any of the business referred to in sub-clause (i), (ii) and (iii) above.

C) In addition to the above data, proposal should also include a letter of willingness to resign his/her post and to join as Member, HERC if selected.


D) A declaration in the form of undertaking is also required to be submitted along with the application on the following points:

- i) That he/ she does not have any financial or other interest which is likely to affect prejudicially his/ her function as Member, Haryana Electricity Regulatory Commission.
- ii) Whether any criminal case has been registered against applicant?
- iii) Whether applicant has been charge-sheeted for any criminal offence? If yes, the details thereof.
- iv) Whether applicant has been convicted by any competent court for any criminal offence? If yes, the details thereof.

E) In addition to the above, the application should also include the following information/ documents:-

- i. Experience certificate in their respective field from their employer/ex-employer or from the organization with which they are/were associated with.
- ii. ACR of the last five years and integrity certificate from their organization in case of those persons who are working in Government or PSUs.
- iii. Candidates who have retired from Government or PSUs are to submit ACR record of last five years of their service and integrity certificate from the organization from which they have superannuated.
